

_____ (hereafter "Team"), represented by its administrators including Manager, agrees to designate the following individual as a motor boat driver at the Canadian International Dragon Boat Festival Society (hereafter "Society") Club from

_____ (hereafter "Driver")

The Team through its Administrators, and its Driver agree to the following:

- That the Administrators have acknowledged all the terms previously set out in the Coach Boat Team User Agreement.
- That the Administrators have shared all pertinent information with their Team and Driver.
- That the Administrators and Driver have read and agree to all Club policies including:
 - The Driver shall be listed as a designated driver on the team's Coach Boat Roster;
 - The Team, its administrators, and its drivers are individually, jointly, and collectively liable for any damages to the boat, equipment, or other parties stemming from the use and control of the motor boat. The team is also responsible for the Driver following Club rules;
 - The Team, its administrators, and its drivers are responsible for ensuring the Driver is fully aware of their responsibilities, is properly trained and equipped to safely and competently use the boat, and is following all laws and regulations regarding using a motorized boat including:
 - Carrying a valid Pleasure Craft Operator Card at all times while driving the boat;
 - Following Transport Canada's Safe Boating Guide guidance; and
 - Not being at any time under the influence of mind-altering substances including alcohol, drugs, medication, or other treatments;
 - The Club may require the Team's drivers and/or other officials, if their ability to fulfill their role is in question: complete safety or other training at the Team's cost, or present additional documentation; and
 - Failure to meet these standards may lead to a suspension of equipment use without credit or refund.

INDEMNITY AND LIABILITY RELEASE: The Team, its Administrators, and boat drivers, on their individual, joint, and collective behalf (collectively User), voluntarily releases and indemnifies the Society and all of its agents including employees, sponsors, and affiliates, from all present and future liability/claims that may be made by the User (or their family members, estate, heirs, or assigns of the undersigned or others) resulting from the User's use or operation of the Society's motorized boats and associated equipment, including but not limited to (i) negligence or misconduct (active, passive, or gross) (ii) loss/damage of personal property, personal injury, or death of the User's members or third parties arising as a result of using the motor boat and other equipment, and (iii) all activities incidental to the use and operation of the motor boat. The User uses and operates the boat with knowledge of the dangers involved, and accepts all inherent risks of and assumes full responsibility for any property damage, personal injury, or death to the User or others. The User certifies that this release extends to all claims arising on and after the execution and that the facts in which this release is given may prove to be different than the facts now known or believed.
