 - That the Administrators and team members have read and agree to all Club policies including:
 - The Team is solely and fully responsible for any damages to the boat, equipment, or other parties from the use and control of the boat. All team members are aware of this liability.
 - Any repairs undertaken as a result of damage to boats or equipment will be repaid in full by the Team. Damages, losses, or write-offs will be charged back to the Team.
 - The Administrators are responsible for following best practices for proper and safe operation of the boat including lighting requirements during non-daylight hours, minimum safety equipment, and ensuring a competent/trained steers is used during practices on the water.
 - The Club may require the Team's chosen steerspeople, coaches, managers, or other officials, if their ability to fulfill their role is in question: complete safety or other training at the Team's cost, present additional documentation, or proof of liability coverage.
 - The Administrators are responsible for ensuring the team adheres to all laws, regulations, and rules regarding movement, right of way, clear water rules, and non-interference with wildlife.
 - The Administrators will enforce boat safety/capacity, and ensure approved PFDs are always worn.
 - The Club may rotate teams through different types of dragon boats, limit access, or close the facility for any reason including damage, use for other events, or safety. In cases where practices are impacted by Club restriction or closure, the Team may rebook subject to availability during the team's practice season. No refund, partial or otherwise, will be given.
 - The Administrators will ensure their boat departs and returns in a timely manner.
